



## **CERTIFIED PROFESSIONAL IN EROSION AND SEDIMENT CONTROL REVIEW AND EXAM SEMINAR**

The CPESC accreditation shows a recognized specialization in soil erosion and sediment control measures. The course will be held at the Chicago Center for Green Technology (CCGT).

Please note that all participants are separately required to submit an application and fee to become eligible to take or re-take the exam. Typical review time periods for these applications are 30 days. This application or re-test fee is not included in the seminar fee and is the responsibility of the participant. John has also served on the Board of the International Erosion Control Association, including being its President, and he continues to serve the erosion control industry as an instructor for both the CPESC and CISEC certification programs.
