Usually by this time of the session, budget bills have begun to move, but so far this year there has been no action on a state budget package in either chamber. Individual agency bills have been entered and are awaiting action in their respective committee or may still be in rules or assignments without yet being assigned to any specific committee. Both HB3595 and SB2466 are currently waiting for further action. HB3595 has been assigned to the Appropriations-General Services Committee but has received no action. SB2466 remains in the Senate Assignments Committee awaiting assignment to the Senate Appropriations II Committee. Both bills address the Department of Agriculture budget for FY14, and both bills contain a \$515,000 increase in the line for Grants to Districts.

There is some indication that the pension issue will be dealt with within the next few days, but there are no guarantees and even though parts of the pension solution have been subjected to "test" votes, no votes have been taken on a complete package that will deal with the entire issue. Hopefully the issue will be addressed soon, and the collective attention of the General Assembly can move on to decisions affecting funding the state's pro-

The IUM Technical Review Committee met in April. The TRC is working on the following standards: Soil Bioengineering


