NACD ANNUAL MEETING

The NACD Annual Meeting was held in New Orleans, LA on January 30th – February 4, 2015. Illinois had great representation at the event: Myron Kirby, Tom & Judy Beyers, Lee & Marie Bunting, Terry & Coleen Bogner, Lonnie Wilson, Tara Hopkins and myself all attended. The event featured some great session topics and many tours were offered for those not interested in sessions. AISWCD donated an Armalite M-15 riffle to the auction and it brought \$1400.00! Overall, it was a great conference!

I attended the Executive Director's breakfast on Sunday and sessions on both Monday and Tuesday. All three events were very useful. I met several Executive Directors from throughout the nation: Maine, Maryland, Montana, Indiana, Ohio, Delaware and many more. Each state Association is set-up and funded very differently. We all gathered information and new ideas to bring back to our state.

LEGISLATIVE UPDATE

The legislative session is in full swing. The committees have been appointed, Governor has given his State of the State Address and we are diligently working with Mike Hoffmann (AISWCD Lobbyist) to set-up meetings with legislators. Mike and I have set-up a meeting for Representative C.D. Davidsmeyer to meet with the SWCDs within his district on Tuesday, February 10th. Thank you to the SWCDs for agreeing to participate and to the employees for helping get Directors present. Remember, you can never over inform your legislators. The more they know about SWCDs and your activities the more helpful it is when Myron, Mike and I meet with them at the Statehouse. They will also be more likely to support legislation for funding if they know the importance of an SWCD!

Legislative Day 2015 is Tuesday, March 10th from 10:30am – 6:00pm. In addition to our afternoon Legislative visits, we will again have a reception at Boone's Saloon from 4:00pm-6:00pm. Last year as Legislators came into the reception the main question that was asked, "Is there someone here from my area?" While we had a fairly good turnout of participants, there were very few Legislators that were able to talk directly to their constituents due lack of SWCD representation at the reception. We would really encourage each district to have a least one representative present for the reception from 4:00pm-6:00pm. We understand that, for most, it's a long drive to and from Springfield. However, having a constituent present from the Legislator's district is key to having them understand what Districts do and why they are important. Please consider sending a representative to this year's event!

Envirothon Resolution was passed yesterday by the House. The Resolution designates April 30, 2015 and April 28, 2016 to be recognized as "Envirothon Day" in Illinois. We are also working with Mike Hoffmann to have one of the sponsors or co-sponsors present the Resolution at the event. Stay tuned!
