

CDSI – CLIENT GATEWAY/CRP SUB-AGREEMENTS

Great news ... The Sub-Agreements were emailed through IL.ALL on Tuesday, May 26th. If you District is interested in participating there several key dates that will require action.

June 1st – Notify AISWCD if your District is interested in participating in the Sub-agreement. AISWCD will forward the workable documents associated with the Sub-agreement.

June 8th – Attachment C-Plan of Work (Admin & CRP) is due to AISWCD.

June 11th - Mark your Calendars! CDSI-Client Gateway TRAINING - NRCS will be hosting webinar training on <u>June 11th from 9am-12pm.</u> This is a webinar so it is likely that you will not need to leave your office to attend. If your District is unable to participate in this training, the training webinars are recorded and can be viewed at a later date/time.

June 15th – Sub-agreement and required attachments needs to be signed and submitted to AISWCD by COB.

I have received numerous questions regarding the agreement...all of which are excellent questions to ask. The CDSI portion is new to AISWCD, SWCDs and NRCS so the workload is not certain. Please see the attachment for a list of Q/A regarding the Sub-agreement.

LEGISLATIVE UPDATE

Unfortunately I have some disappointing news regarding funding, of which most Districts suspected for some time. The remaining FY15 funds for District Operations will not be released. The amount was approximately \$18,000 per District. Myron Kirby sent a letter, via IL.ALL, early last week explaining the funding situation. Both the House and Senate have passed a budget (HB4158) which leaves SWCDs at \$7.5 million. While this seems like a great move on their part, there is a catch. The House and Senate are not sending the budget bills to the Governor as usual. The bills will be held until both the Senate and House reach a budget deal with the Governor. The Governor would like to see his "Turnaround Agenda" items passed before discussing the budget. The House and Senate will keep summer hours to allow time to work on both the budget and the Turnaround Agenda items. The House is back in session on Thursday, June 4th and the Senate is back on Tuesday, June 9th.

PLEASE CONTINUE TO COMMUNICATE WITH YOUR LEGISLATORS!

Discuss with them *how funding cuts from FY15 will and are affecting their legislative district* and the state as a whole. Keep reminding them throughout the legislative session on how important Soil and Water Conservation is to Illinois. Legislators need to hear from their constituents. One last time, I can't stress how important it is to call your legislator to let them know how the FY15 funding cuts have not only affected SWCDs but their legislative district as well. Please continue to carry this message throughout the year as it is imperative that we are all carrying a clear and concise message.

SB0543 – EPA-Coal Combustion By-Product

Passed both the House and Senate. The bill does as follows -

Provides that "coal combustion by-product" means coal combustion waste when used as a functionally equivalent substitute for agricultural lime or mined gypsum (calcium sulfate dihydrate) as a soil conditioner, amendment, fertilizer, or other agricultural purposes when using appropriate agronomic rates.

AISWCD supported this Bill

- ✓ provide information or examples of what they have found works to key stakeholders, and members of the national Network.

The Conservation Innovation Grant funded program has the goal of increasing awareness of soil health concepts and increasing the acreage under soil health management. While some of the items listed above are already taking place within your SWCD, we don't want those local efforts and leaders to go unrecognized. Please nominate today!
